TEACHER CERTIFICATION POLICY

Initial Certification

Faculty members must be college graduates that are certifiable by ACSI. Initially a Washington State Teacher's Certificate or a certificate from another state will be accepted.

Required Certifications

A Standard Level, ACSI Certificate in field of service or obtained within 2 years of employment is required. A Washington State Teacher's Certificate in field of service or equivalent is coveted in addition to the ACSI required one.

Certification Policies

- 1. All teachers who initially do not have an ACSI Standard Certificate must obtain at least Standard Level Certification within their two years of employment as a teacher. (Eighteen Continuing Units of Bible [6 semester hours] and a course in the Christian philosophy of education are required.) ASCI Certification must be maintained in order for employment to continue at Valley Christian School.
- 2. A Washington State Teacher's Certificate is coveted, in addition to the ACSI Certificate. The teaching certificate must be in the field of assigned teaching responsibilities and kept up to date.

- 3. If a teacher is teaching outside his/her field of certification an active and documented plan to be certified in the field must be pursued. This plan must be submitted to the school administrator.
- 4. If ACSI Standard Certification cannot be obtained within the noted time constraints or expires, a written request for extension must be submitted to the administrator. The plan to obtain the required certifications and progress toward certification must be included. Valley Christian School reserves the right to end a teacher's employment if ACSI Certification is not acquired or maintained.
- 5. Educational administrators must also carry appropriate in-field certifications from ACSI and Washington State or equivalent.
